Resolved, That Resolution 2023-R-40 authorizes the allocation of public funds to the Stoneridge Neighborhood Association in the amount of \$1,000.00 from the 2022-23 FY Discretionary Fund of Councilor John London to be used exclusively for landscaping materials and the installation of the neighborhood sign along the entrance to the Stoneridge Subdivision in the City's right-of-way. 2. Resolved, That Resolution 2023-R-41 authorizes Mayor James D. Stewart, Jr. to enter into an agreement with Alabama Power Company for surveillance camera installation at the City of Irondale Civic Center in an amount not to exceed \$412.63/month plus energy usage costs. (*Doss*)
3. Resolved, That Resolution 2023-R-42 accepts the bid for the 2023 Road Paving Plan for paving in the amount of \$2,285,888.52 from MidSouth Paving, Inc. and authorizes Mayor James D. Stewart, Jr. or his designee to execute an agreement for the same. (*City*)
