Resolved, That Resolution 2024-R-96-A amends Resolution 2024-R-96 authorizing the execution of a service agreement with Heidi's Kids in the amount of \$7,500.00 for the provision of food and support to low-income children and families in need in the community with funding being as follows: \$2,500.00 from the Irondale Community Programs budget, \$1,000.00 from the FY 2023-24 Discretionary Fund of Mayor James D. Stewart, Jr., \$1,000.00 from the FY 2023-24 Discretionary Fund of Councilor John London, \$1,000.00 from the FY 2023-24 Discretionary Fund of Councilor Aaron
