**SERVICE AGREEMENT**

This Agreement is made and entered into by and between the **City of Irondale, Alabama**, a municipal corporation (hereinafter referred to as the "City"), and **Community Food Bank of Central Alabama**, an Alabama non-profit corporation (hereinafter referred to as the "Contractor").

**WHEREAS**, the Contractor provide food assistance services to residents of the City of Irondale who are experiencing food insecurity; and

**WHEREAS**, the City is desirous of obtaining Contractor's services as designated below and finds that a public purpose is served through the obtaining of Contractor's services as set forth herein.


**NOW, THEREFORE, IN CONSIDERATION** of the premises and the mutual promises of the parties hereinafter set forth, the parties agree as follows:

1. This Agreement shall be for a one (1) year period beginning on the date of the last party to execute this Agreement.
2. Contractor hereby agrees to provide food assistance services to the City of Irondale for residents with food insecurity in the City.
3. The City shall pay to the Contractor a total of Five Hundred Dollars (\$500.00). Payment will be made upon receipt of a copy of Contractor's most recent financial information and any other reports and information deemed appropriate and requested by the City.
