Councilor Box made a motion to enter Public Hearing. Councilor Sims seconded the motion. A vote was held and this motion passed unanimously.

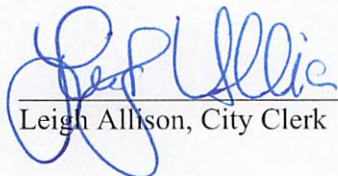
Councilor Sims made a motion to exit Public Hearing. Councilor Box seconded the motion. A vote was held and this motion passed unanimously.

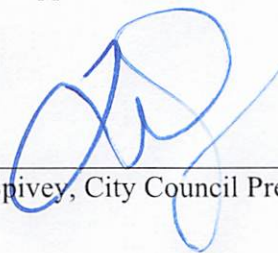
XVI. Adjournment
