XIV. Consent Agenda

Councilor Cuellar made a motion that all items on the Consent Agenda be approved. Councilor Box seconded this motion. A vote was held and this motion passed unanimously.

1. Resolved, That Resolution 2022-R-231 authorizes Mayor James D. Stewart, Jr. to enter into an agreement with Alabama Power Company for surveillance camera installation at the City of Irondale water shop in an amount not to exceed \$402.45/month plus energy usage. *(City)*
2. Resolved, That Resolution 2022-R-232 authorizes the execution of a service agreement with I Am Love Ministries in the amount of \$500.00 from the 2022-23 FY Discretionary Fund of Councilor John London to be used exclusively for the promotion of youth athletics in the City of Irondale for a Youth Athletics Banquet. *(London)*
3. Resolved, That Resolution 2022-R-233 authorizes an extension of the Moratorium on short-term rentals within the City of Irondale, Alabama enacted in Resolution 2022-R-164 until April 1, 2023. *(City)*

4. Resolved, That Resolution 2022-R-234 authorizes the execution of a service agreement with Studio By The Tracks in the amount of \$1,500.00 to provide services to the City of Irondale to provide for those in the community with special needs and to create a community and career path for those individuals. *(City)*
5. Resolved, That Resolution 2022-R-235 authorizes the purchase of real estate at 4233 Hood Drive, 4239 Hood Drive, and 2178 Ruffner Road for the purchase price of \$425,000.00 plus closing costs and Mayor James D. Stewart, Jr.'s execution of any documents necessary to effectuate such purchase transaction. *(City)*
6. Resolved, That Resolution 2022-R-236 approves the provision of In-kind Services by the City for Marty's GM St. Patrick's Day Party and declaration of Public Purpose. *(Spivey)*

Councilor Sims made a motion that all rules that would prevent the immediate consideration of Ordinance 2022-32 be suspended. A roll call vote was held and this motion failed with Councilors London, Cuellar, Box and Spivey voting against the motion and Councilor Sims voting in favor.


XVII. Adjournment
