If work involves plumbing fixture additions on the Public Sewer, proof is required that impact fees were paid to Jefferson County prior to issuance of a plumbing permit. **WATTS # 7 OR EQUIVALENT BACKFLOW PREVENTER AND A CUT-OFF VALVE** must be installed within 4 feet from the water meter on the customer side of water service or repair to existing water service to Irondale Water System. Irrigation requires a RPZ (009 style) or atmospheric vacuum breaker.
