

RESOLUTION NO. 2020-R-40

A RESOLUTION TO PROVIDE FOR THE APPOINTMENT, NOTIFICATION AND COMPENSATION OF OFFICERS TO HOLD THE REGULAR MUNICIPAL ELECTION CALLED FOR AUGUST 25, 2020, AND A RUNOFF ELECTION TO BE HELD, IF NECESSARY, FOR OCTOBER 6, 2020.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF IRONDALE, ALABAMA, as follows:

Section 1. That pursuant to the provisions of Section 11-46-24, 1975 Code of Alabama, the following named persons be and they are hereby appointed as officers to hold the regular municipal election heretofore called for August 25, 2020, and a runoff election to be held, if necessary, for October 6, 2020, in the City of Irondale, Alabama, namely:

Section 2. That the Mayor be and is hereby authorized and directed to publish or cause to be published, a list of the election officers appointed as aforesaid and the voting places for which said officers have been appointed, either by posting same at three public places in the City of Irondale or by publishing such list in a newspaper published in the City of Irondale at least ten (10) days prior to said election

Section 3. That the Mayor shall notify, or cause to be notified, each of the officers named in Section 1 hereof of their appointment, which said notice shall be served upon them by the Chief of Police or by any police officer of the City of Irondale, Alabama.

Section 4. That the Mayor and City Clerk be and they are hereby authorized and directed to pay, or cause to be paid, out of the general funds of the City, the fees set by the Acts of the Legislature for the State of Alabama for elections held in Jefferson County, Alabama, for the same or similar election officials and the election of officers herein appointed on proper proof of service rendered by said officers at said election.

Section 5. That the Mayor and City Clerk be and they are hereby authorized and directed to hold, or cause to be held, a school of instruction for the officers appointed to conduct said regular municipal election. The City Clerk is further directed to notify such officers of the time and place of holding such school of instruction and to publish notice thereof in the manner prescribed by law at least forty-eight (48) hours before such school is held.

Section 6. That the Chief of Police, pursuant to and in the manner prescribed by Section 11-46-28(i) 1975 Code of Alabama shall preserve good order at said municipal election.

Section 7. That the provisions of this ordinance shall become effective immediately upon its passage and approval by the City Council of the City of Irondale, Alabama.
