

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Irondale, Alabama, as follows:


1. That **James D. Stewart Jr.** received a majority of the votes cast for the office of **Mayor**, and is hereby declared to be elected to that office for the term beginning on the first Monday in November, 2020.
2. That **John London** received a majority of the votes cast for the office of **District 1**, and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
3. That **Cindy Cuellar** received a majority of the votes cast for the office of **District 3**, and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
4. That **Bobby Joe Wilson** received a majority of the votes cast for the office of **District 5** and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
5. That no candidate received a majority of the votes cast for the office of **District 4**, and that **Robert Box** and **Gregory C. Townsend** received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on **Tuesday, October 6, 2020**, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
