

**Resolution 2021-R-59**


*Authorizing the execution of an agreement with PME Sports and Top Ten Management, LLC

**WHEREAS**, it is beneficial to the youth of the City of Irondale, Alabama ("City") to participate in recreational sporting; and


**WHEREAS**, the City finds that a public purpose is served through the provision of these services by PME Sports and Top Ten Management, LLC.





**EXHIBIT A**

**SERVICE AGREEMENT**

This agreement made and entered into by and between the City of Irondale, Alabama, a municipal corporation, and PME Sports and Top Ten Management, LLC (collectively, "Contractor").

**WHEREAS**, Contractor desires to perform certain recreational sporting services for the youth of the City of Irondale; and


**WHEREAS**, the City is desirous of obtaining their services as designated below.

**THEREFORE**, the parties hereto promise, covenant and agree as follows:

1. The Contractor hereby agrees to provide recreational sporting services to the youth within the City. Such services shall include, but not be limited to, youth sporting events to be held at Shades Valley High School.
2. In consideration of the services to be performed by Contractor, the City does hereby agree to pay to said Contractor the sum of Five Hundred and NO/100 Dollars and 00/100 (\$500.00).
3. Contractor shall provide to the City as soon after the end of the preceding fiscal year as practicable an audit report and any other reports and information deemed appropriate by the City Clerk/Treasurer of the City.
4. This agreement shall be for a three (3) month period beginning on the date of execution of this agreement.
