

RESOLUTION 2021-R-54

**AUTHORIZING THE EXECUTION OF AGREEMENTS
WITH JEFFERSON COUNTY, ALABAMA
FOR ROADWAY PROJECT ON GRANTS MILL ROAD**

WHEREAS, the Jefferson County Commission entered into an agreement with the City of Irondale for maintenance of roads and portions of roads located in the City limits of Irondale as of April 26, 2018 (Minute Book: 172, Pages: 103-104) (“Thru Road Agreement”);

WHEREAS, Grants Mill Road from Old Leeds Road to the southeasterly City limits of Irondale is one of the aforementioned roads; and

WHEREAS, this portion of roadway is being resurfaced and realigned as part of Jefferson County Project No. 37-18-378 (“the Project”); and

WHEREAS, work under the Project is beyond the scope of maintenance covered by the Parties’ Thru Road Agreement; and

WHEREAS, the County and Irondale desire to enter into these Agreements for the public purpose of coordinating and providing utility relocation work along Grants Mill Road as a part of the Project.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Irondale at a regular meeting, duly assembled, a quorum being present that Mayor James D. Stewart, Jr. is authorized to execute an Agreement to Share Responsibilities (Joint Services Agreement) for Jefferson County Project No. 37-18-378, a Non-reimbursable Agreement for Relocation of Utility Facilities on Public Right-of-Way, and any other document related to such agreements. Such agreements shall be in substantially the forms attached hereto as Exhibit 1 and Exhibit 2.
