## **Exhibit A**

**SERVICE AGREEMENT**

This agreement made and entered into by and between the City of Irondale, Alabama, a municipal corporation (hereinafter referred to as the “City”) and **ClasTran**, an Alabama non-profit corporation (hereinafter referred to as the “Contractor”).

**WHEREAS**, the Birmingham Regional Paratransit Consortium, doing business as ClasTran, is a nonprofit (501-C-3) corporation formed in June of 1997 to coordinate specialized transportation (paratransit) services in Jefferson County, Alabama; and

**WHEREAS**, ClasTran serves clients who reside within the City of Irondale; and

**WHEREAS**, the City of Irondale recognizes the need for specialized transportation (paratransit) services for its citizens and is desirous of obtaining Contractor’s services as designated below and finds that a public purpose is served through the obtaining of such services.

**THEREFORE**, the parties hereto promise, covenant and agree as follows:

1. Contractor hereby agrees to provide specialized transportation (paratransit) services for the citizens of the City.
2. The City shall pay to the Contractor a total of **One Thousand Eight Hundred Seventy-Five Dollars and 00/100 (\$1,875.00)**. Payment will be made upon receipt of a copy of Contractor’s most recently completed audit and any other reports and information deemed appropriate and requested by the City.
3. Absent any determination of intentional default, this agreement shall renew annually upon the approval of the then current fiscal year budget by the City Council under the same terms and conditions unless **(1)** canceled on sixty (60) days written notice by either party; or, **(2)** funds are not appropriated to the Contractor by the Irondale City Council in such budget.
