EXHIBIT A

SERVICE AGREEMENT

This agreement made and entered into by and between the City of Irondale, Alabama, a municipal corporation, (“City”) and I am Love Ministries, LLC (collectively, “Contractor”).

WHEREAS, Contractor desires to promote youth athletics in the City and to perform certain recreational promotional services for the youth of the City of Irondale; and

WHEREAS, the City is desirous of obtaining their services as designated below.

THEREFORE, the parties hereto promise, covenant and agree as follows:

1. The Contractor hereby agrees to promote and provide youth athletic promotional services for the youth within the City. Such services shall include the holding of a Youth Athletic Banquet in December, 2022.
2. In consideration of the services to be performed by Contractor, the City does hereby agree to pay to said Contractor the sum of Five Hundred and NO/100 Dollars (\$500.00).
3. Payment will be made upon receipt of a copy of Contractor’s most recently completed financial statement and any other reports and information deemed appropriate and requested by the City.
4. This agreement shall be for a one (1) month period beginning on the date of execution of this agreement.
