EXHIBIT A

SERVICE AGREEMENT

This agreement made and entered into by and between the City of Irondale, Alabama, a municipal corporation, ("City") and I am Love Ministries, LLC (collectively, "Contractor").

- 4. This agreement shall be for a one (1) month period beginning on the date of execution of this agreement.
