Exhibit A

AGREEMENT

This Agreement is made and entered into by and between the **City of Irondale, Alabama**, a municipal corporation (hereinafter referred to as the “City”), and **Studio By The Tracks**, a non-profit corporation (hereinafter referred to as the “Contractor”).

WHEREAS, the Contractor performs certain services for the citizens of the City of Irondale, Alabama;

WHEREAS, the Contractor provides a studio and gallery for adult artists with autism and also provides a social network and a career path that enriches our artists’ lives and betters the community; and

WHEREAS, the City is desirous of obtaining Contractor’s services as designated below and finds that a public purpose is served through the obtaining of Contractor’s services as set forth herein.

NOW, THEREFORE, IN CONSIDERATION of the premises and the mutual promises of the parties hereinafter set forth, the parties agree as follows:

1. Studio By The Tracks hereby agrees to provide services to the City of Irondale to provide a place to do art for those in the community with special needs in order to promote the health, safety and welfare of those citizens.
2. The City shall pay to the Contractor a total of One Thousand Five Hundred Dollars (\$1,500.00). Payment will be made upon receipt of a copy of Contractor’s most recently completed financial statement and any other reports and information deemed appropriate and requested by the City.
3. Absent any determination of intentional default, this agreement shall renew annually under the same terms and conditions unless (1) canceled on at least sixty (60) days written notice by either party prior to any subsequent renewal date and delivered to the other party in person or by certified mail; or (2) funds are not appropriated by the Irondale City Council.
