## **Exhibit A**

**AGREEMENT**

This Agreement is made and entered into by and between the **City of Irondale, Alabama**, a municipal corporation (hereinafter referred to as the "City"), and **United Way Area of Central Alabama, Inc.** (hereinafter referred to as the "Contractor").

**WHEREAS**, the Contractor performs certain services for the senior citizens of the City of Irondale, Alabama; and

**WHEREAS**, the City is desirous of obtaining Contractor's services as designated below and finds that a public purpose is served through the obtaining of Contractor's services as set forth herein.

**NOW, THEREFORE, IN CONSIDERATION** of the premises and the mutual promises of the parties hereinafter set forth, the parties agree as follows:

1. Contractor hereby agrees to provide programs for the benefit of the senior citizens of the City of Irondale to include the Meals on Wheels Program.
2. The City shall pay to the Contractor a total of Five Thousand and 00/100 (\$5,000.00). Payment will be made upon receipt of a copy of Contractor's most recently completed audit and any other reports and information deemed appropriate and requested by the City.
3. Absent any determination of intentional default, this agreement shall renew annually under the same terms and conditions unless **(1)** canceled on at least sixty (60) days written notice by either party prior to any subsequent renewal date and delivered to the other party in person or by certified mail; or **(2)** funds are not appropriated by the Irondale City Council.
