EXHIBIT A

SERVICE AGREEMENT

This agreement made and entered into by and between the City of Irondale, Alabama, a municipal corporation, and Irondale Mounties Youth Sports LLC, a domestic limited liability company (collectively, "Contractor").

WHEREAS, Contractor desires to perform certain community recreational sporting services for the youth of the City of Irondale, specifically youth football and cheerleading; and

WHEREAS, the City is desirous of obtaining Contractor's services as designated below.

THEREFORE, the parties hereto promise, covenant and agree as follows:

1. The Contractor hereby agrees to provide recreational sporting services to the youth within the City. Such services shall include youth football and cheerleading in the fall of 2023.
2. In consideration of the services to be performed by Contractor, the City does hereby agree to pay to said Contractor the sum of Five Thousand and NO/100 Dollars (\$5,000.00).
