**Exhibit A**

**SERVICE AGREEMENT**

This agreement made and entered into by and between the **City of Irondale, Alabama**, a municipal corporation (hereinafter referred to as the “City”) and **Boys and Girls Club of Central Alabama**, an Alabama non-profit corporation (hereinafter referred to as the “Contractor”).

**WHEREAS**, the Boys and Girls Club of Central Alabama provides a safe environment for youth in central Alabama to reach their full potential as productive, caring, and responsible citizens; and

**WHEREAS**, Boys and Girls Club of Central Alabama serve youth who reside within the City of Irondale; and

**WHEREAS**, the City of Irondale recognizes the need for a safe environment for youth in the City of Irondale to go and be motivated to reach their full potential as responsible citizens.

**THEREFORE**, the parties hereto promise, covenant and agree as follows:

1. Contractor hereby agrees to provide Sports and Recreation as well as other program services to the youth of the City.
2. The City shall pay to the Contractor a total of **Two Thousand Five Dollars and 00/100 (\$2,500.00)**. Payment will be made upon receipt of a copy of Contractor’s most recently completed audit and any other reports and information deemed appropriate and requested by the City.
3. Absent any determination of intentional default, this agreement shall renew annually upon the approval of the then current fiscal year budget by the City Council under the same terms and conditions unless **(1)** canceled on sixty (60) days written notice by either party; or, **(2)** funds are not appropriated to the Contractor by the Irondale City Council in such budget.
