

Resolution 2024-R-143

*A Resolution authorizing the acceptance and execution of two change orders
for the Ellard Dog Park Project*

WHEREAS, the invitation to bid for the Ellard Dog Park Project (“Project”) was prepared in compliance with the provisions of the Alabama Bid Law;

WHEREAS, the City Council of the City of Irondale, Alabama awarded said bid to Rotolo Consultants, Inc. in the amount of \$886,200.00 on December 19, 2023 by Resolution 2023-R-193;

WHEREAS, work has commenced on the project;

WHEREAS, on August 6, 2024, the City Council approved Resolution No. 2024-R-135 authorizing the execution of two change orders for a new contract sum of \$881,375.00; and

WHEREAS, the City has determined an additional change order is needed in the amount of \$904.80 (attached hereto as **Exhibit A**) for a new total contract sum in the amount of \$882,279.80.




