

RESOLUTION 2024-R-178-B

A Resolution to Amend the Amount of Public Funds Allocated to Jefferson County, Alabama for the construction of a storm shelter in the City of Irondale.

WHEREAS, the City Council approved Resolution 2022-R-118 on July 19, 2022 authorizing the City to enter into an agreement with Jefferson County, Alabama authorizing Jefferson County to construct the “City of Irondale Community Storm Shelter” to be located at 5309 Beacon Drive, Irondale, Alabama;

WHEREAS, the City Council further approved Resolution 2024-R-178 on October 2, 2024 authorizing the allocation of public funds in the amount of \$200,000.00 to cover the costs of expanding the capacity of the storm shelter;


WHEREAS, the City Council further approved Resolution 2024-R-17-A on October 7, 2025 authorizing the allocation of public funds in the amount of \$221,642.70 to cover the costs of expanding the capacity of the storm shelter;

WHEREAS, the City has been notified that there are additional unit items to bridge the unsuitable materials in relation to the Irondale storm shelter parking lot area in the amount of \$75,247.80 and that the City has agreed to pay \$37,623.90 to Jefferson County to cover the City’s portion of the increase in construction costs (as shown on Exhibit A attached hereto); and

WHEREAS, the City desire to amend Resolution 2024-R-178-A accordingly to increase the amount allocated for the storm shelter project from City funds to \$259,266.60.


THEREFORE BE IT RESOLVED by the City Council of the City of Irondale, Alabama, in regular meeting duly assembled, a quorum being present that the amount of Two Hundred Fifty-Nine Thousand Two Hundred Sixty-Six Dollars and 60/100 (\$259,266.60) is hereby allocated to Jefferson County, Alabama to be used exclusively for the construction of a storm shelter in the City of Irondale.






