

**Resolution 2024-R-76**

***A Resolution Fixing Costs of Demolition and Removal of the Structure located at  
5142 Amber Hills Road, Irondale, Alabama***

**WHEREAS**, the Housing Code Abatement Board made a report to the City Council of the City of Irondale, a copy of which is attached hereto as Exhibit A, setting forth the costs of \$10,061.23 for the demolition and removal of the structure located at 5142 Amber Hills Road, Irondale, Alabama (the "Property"); and


**WHEREAS**, the Council finds that the costs set forth in Exhibit A were reasonably incurred in the demolition and removal of the structure on the Property and desires to assess the costs against the Property; and





**THEREFORE, BE IT RESOLVED**, by the City Council of the City of Irondale that the sum of \$10,061.23 is hereby assessed against the property located at 5142 Amber Hills Road, Irondale, Alabama. These costs shall constitute a special assessment against the Property and shall constitute a lien on the property for the amount of the assessment.


