THEREFORE BE IT RESOLVED by the City Council of the City of Irondale, Alabama, in regular meeting duly assembled, a quorum being present as follows:



The bid is comprised of the following:

1300 L.F. ± of 12” ductile iron pipe and appurtenances

3,200 L.F. ± of 8” joint ductile iron pipe and appurtenances

All Bidders must be responsible and meet the criteria, requirements, and applicable 30-day delivery timeframe once the P.O. is issued.

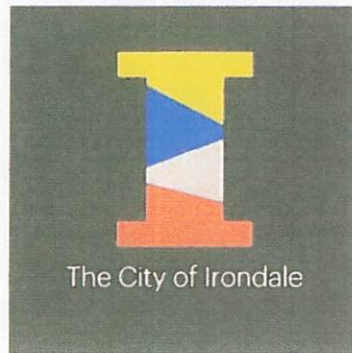

GENERAL INFORMATION

All bidders must use the form provided in the bid package for submitting their bids. All bids must be sealed and marked in the lower left corner "BID – Civic Center Water Main Extension Materials". Late bids will not be opened.

Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request.

Should there be a change in ownership or management, the agreement may be canceled at the City's discretion unless a mutual agreement is reached with the new owner or manager to continue the agreement with its present provisions and prices. The agreement is not transferable by either party.

METHOD OF AWARD

The award will be made to the lowest bidder meeting specifications. It is not the policy of the City to purchase on the basis of low bid only. Quality, conformity with the specifications, terms of delivery and past service and experience are among the factors that may be considered in determining the responsive bidder.

CONTRACT PERIOD

This contract will discharge upon payment and delivery of materials.

LAWS and ORDINANCES

The supplier shall observe and comply with all federal, state, local and municipal laws, ordinances, rules and regulations that would apply to this contract.

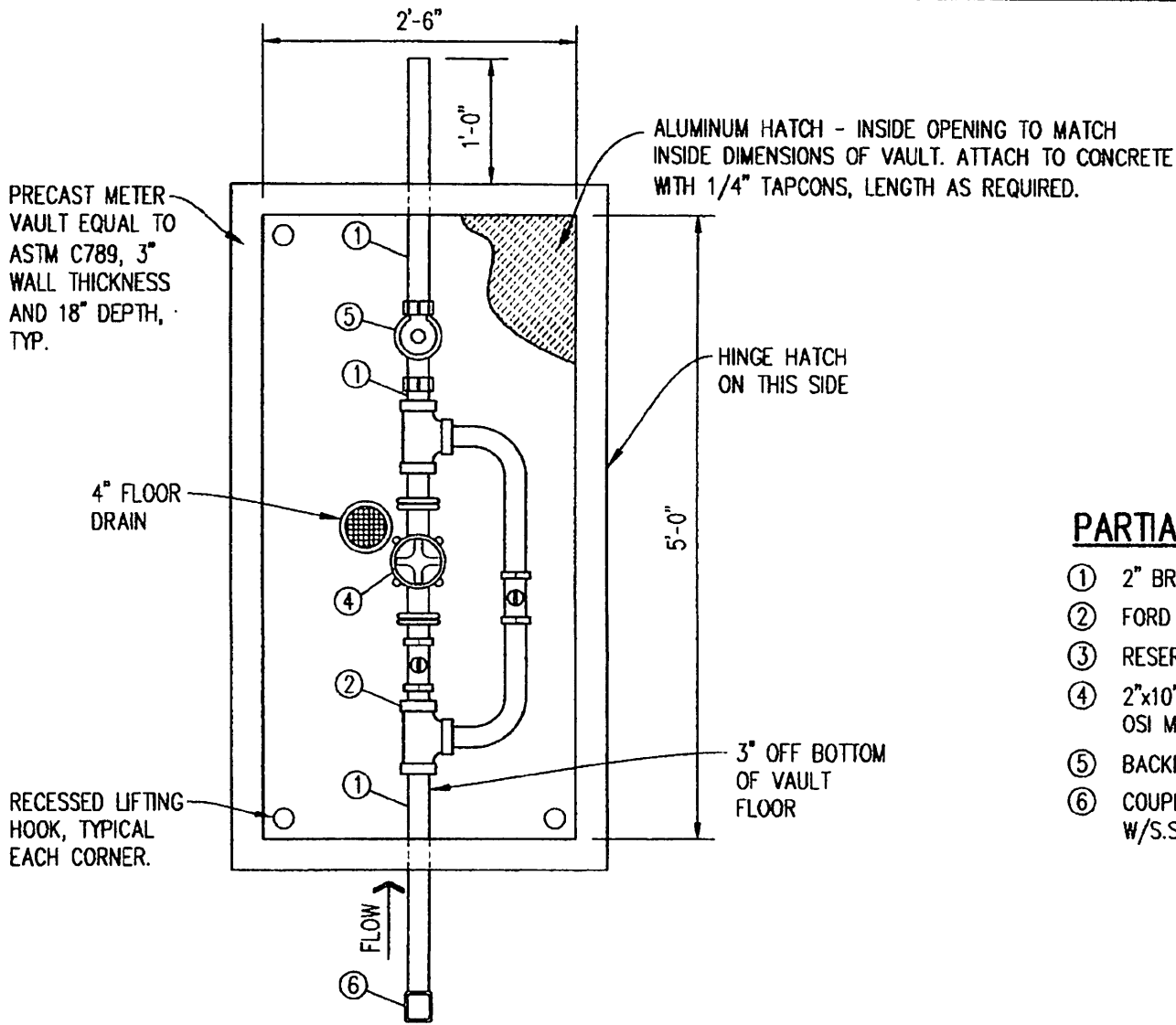

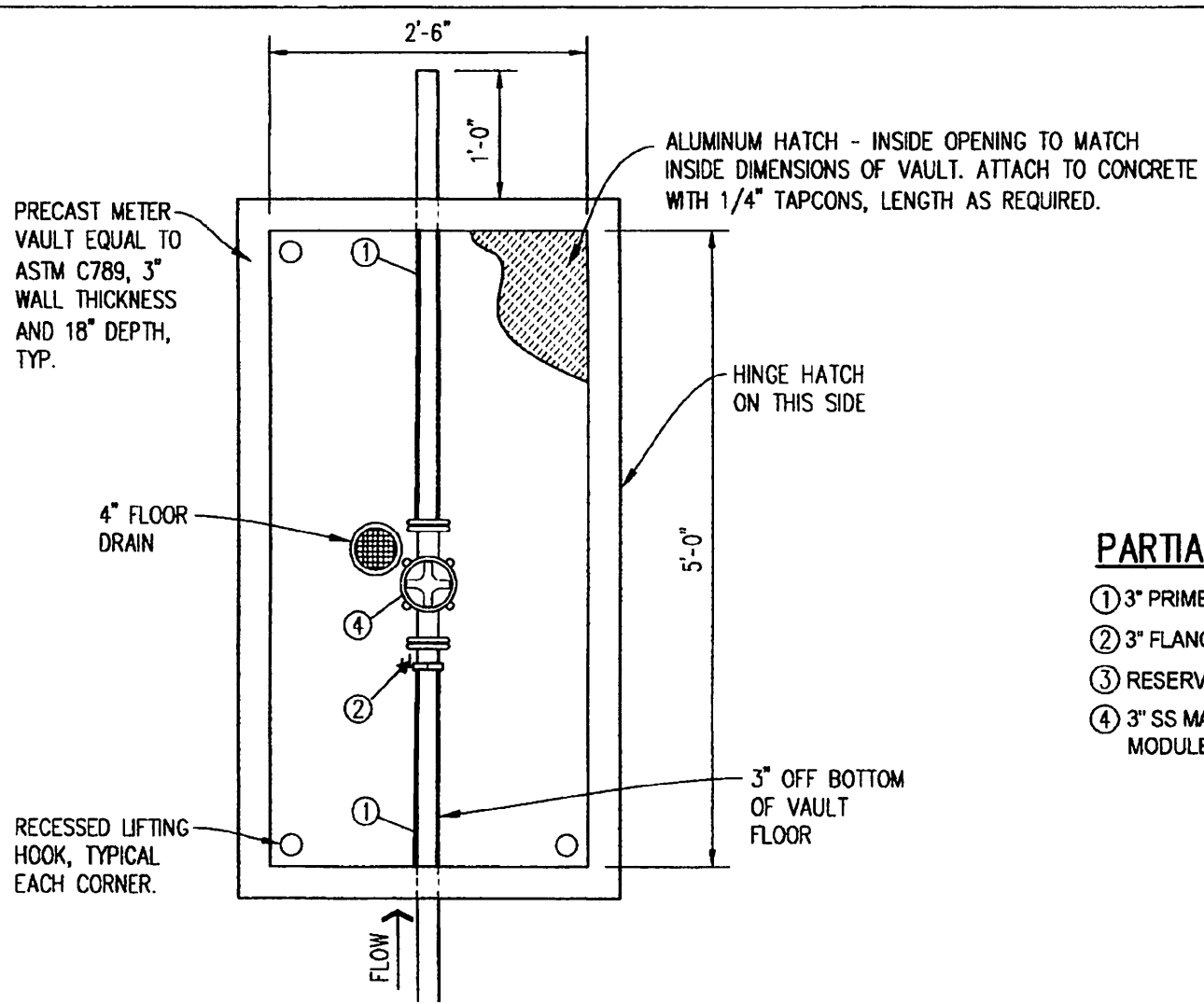
