

EXHIBIT A

SERVICE AGREEMENT

This Agreement is made and entered into by and between the **City of Irondale, Alabama**, a municipal corporation (hereinafter referred to as the "City"), and the **Greater Irondale, Alabama Chamber of Commerce**, an Alabama non-profit corporation (hereinafter referred to as the "Chamber").

WHEREAS, the Chamber was established in 1988 to promote business, commerce and industry in the City of Irondale; and

WHEREAS, the City is desirous of obtaining Chamber's services as designated below.

NOW, THEREFORE, IN CONSIDERATION of the premises and the mutual promises of the parties hereinafter set forth, the parties agree as follows:

2. The City shall pay to the Contractor a total of \$10,000.00 for the provision of the Services.
