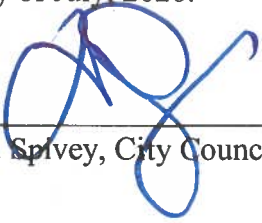


RESOLUTION 2026-R-144

Authorizes the execution of a Service Agreement with The Friends of the Irondale Public Library, Inc.

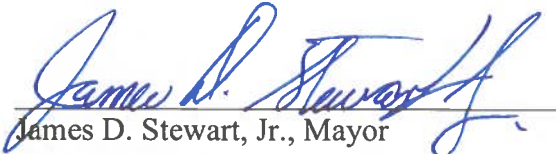
BE IT HEREBY RESOLVED by the City Council of the City of Irondale, Alabama, in regular meeting duly assembled, a quorum being present that Mayor James D. Stewart, Jr., or his designee, is hereby authorized to execute a Community Service Agreement with The Friends of the Irondale Public Library, Inc. (in substantially the form attached hereto as Exhibit A) in the amount One Thousand Seven Hundred Seventy-Five Dollars (\$1,775.00) to be used for library programs, materials and community events that make reading and learning more accessible for all ages. The funding for this is as follows: \$1,075 from the 2025-26 FY Discretionary Fund of Councilor Aaron Sims and \$700.00 from the 2025-36 FY Discretionary Fund of Councilor John London.

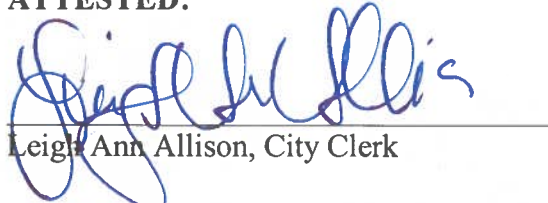

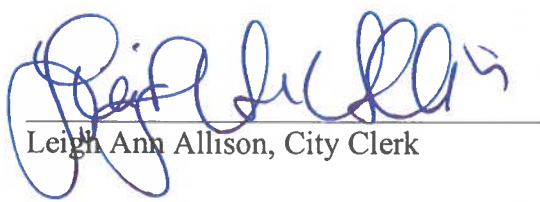

Exhibit A

AGREEMENT

This Agreement is made and entered into by and between the **City of Irondale, Alabama**, a municipal corporation (hereinafter referred to as the "City"), and **The Friends of the Irondale Public Library, Inc.**, an Alabama non-profit corporation (hereinafter referred to as the "Contractor").

WHEREAS, the Contractor performs certain services for the citizens of the City of Irondale, Alabama; and

WHEREAS, the City is desirous of obtaining Contractor's services as designated below and finds that a public purpose is served through the obtaining of Contractor's services as set forth herein.

NOW, THEREFORE, IN CONSIDERATION of the premises and the mutual promises of the parties hereinafter set forth, the parties agree as follows:

1. Contractor hereby agrees to provide services to the citizens of Irondale through library programs, materials and community events that help make reading and learning more accessible for all ages.
2. The City shall pay to the Contractor a total of One Thousand Seven Hundred Seventy-Five Dollars (\$1,775.00). Payment will be made upon receipt of a copy of Contractor's most recently completed financial statement and any other reports and information deemed appropriate and requested by the City.
