Accept a Grant from the State of Alabama Tourism Department***

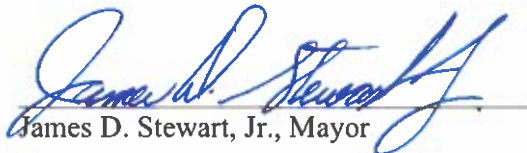

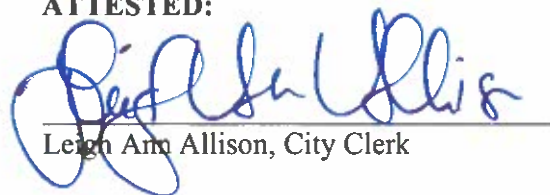

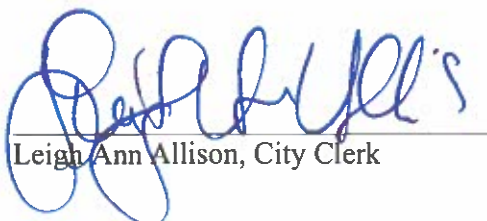

LETTER OF UNDERSTANDING

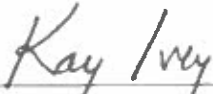
