This Application is made subject to the provisions of Ordinance No. 2020-02 of the City of Irondale, Alabama, which repealed and re-enacted Chapter 7.5 of its Municipal Code entitled "Garbage, Refuse and Trash" (hereinafter referred to as the Ordinance) and the Alabama Solid Waste Disposal Act of the State of Alabama (hereinafter referred to as the "Act") are incorporated herein by reference as if copied herein in full. Customer by signing below acknowledges reading and understanding the provisions of the Ordinance and the Act and agrees to be bound by their terms. Any conflict between the provisions of this Application and the Ordinance shall be resolved in favor of the Ordinance.

Bills are mailed by the 1<sup>st</sup> (first) day of each month. Bills are delinquent after the 16<sup>th</sup> (sixteenth) of each month. A late fee will be applied to all balances on the 17<sup>th</sup> of each month. After 3 (three) consecutive months or 90 days of past due billing your account will be turned over to collections- and all city issued garbage containers will be removed. There will be a \$75.00 non-refundable rental fee payable in full in advance for each replacement garbage container, each additional garbage container and in order to reinstate services. Customers will also be billed an additional monthly rental fee of \$10.00 for each additional garbage container.

Irondale Sanitation is not responsible for the postal system's mistakes or any bills rendered by a 3<sup>rd</sup> party. Failure to receive the bill will not relieve the customer of payment.

Returned checks or electronic payments will be regarded as unpaid bills. The customer will be charged a service charge for each time a check or electronic payment is returned. After two returned checks only money order, cashier's check or credit card will be accepted on said account(s).

The right of exemption to personal property and wages under the Constitution and Laws of the State of Alabama or any other State in the United States, is hereby waived in favor of the obligations assumed herein, and the undersigned agrees to pay all costs of collection, including attorney's fees.

This application for service when executed, becomes a binding contract for the services provided by the respective Sanitation Service and constitutes an agreement to abide by the rules and regulations governing these services including timely payments and protection of State Health Department regulations at the service location. Irondale Sanitation Services are mandatory for each service location.

Billing will be at current rates for class of service and regulations listed above are subject to change without prior public notice.
